### **Privacy Policy**

We have created this privacy policy to demonstrate our firm commitment to protecting information you submit. This privacy policy only applies to transactions made, and data gathered, on the oakvalleyvizag.com web site, and does not apply to any other transactions, information, web site or Internet, telephone or offline point of contact between oakvalleyvizag.com and you or other consumers. You agree that by using the Site you are expressly and affirmatively consenting to our use and disclosure of the information that you provide, and consenting to receive emails, as described below in this privacy policy.

### **Information We Collect From You**
